

## Scientific Activity Report – 2020

During 2020, despite all the challenges and the shutdown caused by COVID-19 pandemic, CEEApIA carried out most of its scientific activities. Its performance was very satisfactory in a few topics, highlighting the publication of 13 articles in AJG (Academic Journal Guide) and JCR (Journal Citation Reports – Web of Science) journals, most of them with high Impact Factor; 8 articles in SCOPUS; and 12 in other journals. Seven books were edited and 27 chapters in books were published. CEEApIA's Working Paper Series has been increased by 5 articles.

The physical presence of CEEApIA researchers in international conferences was brought to almost zero due to travel restrictions. There were, however, 28 participations in conferences, most of them held online. Regarding the organization of events, there was only 2.

It is also important to mention the coordination of 11 projects, 2 of which were R&D services promoted by regional entities, namely Direção Regional do Emprego e Qualificação Profissional and MUSAMI. The provision of services to the regional community is one of CEEApIA's main strategic points for the coming years.

Finally, the last to highlight has been CEEApIA researchers' commitment in supervising both PhD and Master thesis instilling in its students the capacity to conduct research with qualitative and quantitative analysis and to integrate and systematize knowledge, with a total of 33 master thesis and 3 PhD thesis concluded.

During 2020 the center worked on a portfolio of projects worth 1.5 million euros with a potential of 381 thousand euros available for the year. The balance of these projects that transits to 2021 is about 744 thousand euros. Some of the projects are going to be executed in the next two to three years. The projects are the subject of individual reports.






**Graphic 1 – Publications 2020.**




**Graphic 2 – Impact Factor 2020 (JCR journals).**
